With over 700 acres of dedicated parkland under its management, the Park District is charged with maintaining an expansive system of natural resources and facility infrastructure. This includes, but not limited to, an aquatic center, 36-hole championship golf course, antique carousel, boat rental operation, historical museum, skate park, miniature golf course, picnic shelters, nature preserve, and athletic field complexes. 
Board of Commissioners


2023 Tax Levy Allocation


2024-25 Revenue

The Freeport Park District's revenues are derived from several sources including property taxes, replacement taxes, fees, grants, investment earnings and others.



2024-25 Expense

The Freeport Park District has 11 funds that are designated for a specific purpose, including corporate, recreation, retirement, museum operations, golf, debt service, capital projects, special recreation, liability, police and audit.



Percentages may vary depending on the taxing district where the property is located.
